PREFACE



Brice MACKOSSO
President

In 2024, Tournons La Page celebrated its tenth anniversary. A decade of struggles, mobilizations and commitment to democratic alternation. We have reached this symbolic milestone with the strength of a movement rooted in sixteen countries, supported by more than 260 member organizations and united by a shared conviction: democracy is not a luxury, but a vital necessity.

However, the year 2024 has not been easy. It is part of a cycle of political instability that is weakening the African continent and the world. Military transitions have multiplied, often justified in the name of a desire to break away, but too often resulting in the regression of freedoms and the closure of civic space.

Faced with these abuses, our action has never been more urgent.

This year has also been marked by tragic events, which remind us of the great vulnerability of human rights defenders. In Guinea, our comrades Oumar Sylla (alias Foniké Mengué) and Mamadou Billo Bah were forcibly disappeared, amid increased repression against dissenting voices. These disappearances are the symptom of a power that confuses opposition and threat, and of a rule of law that is faltering. We will not cease to demand truth and justice for them, as for all those who pay a high price for their commitment.

This report is a testament to the vitality and resilience of our movement. He looks back at the campaigns we have led, the coalitions we have consolidated — and even expanded, with the creation of TLP-Senegal — the advocacy we have carried out on all continents, and the citizens we have supported in the face of repression. From Dakar to Kathmandu, from Accra to Geneva, our voice has resounded to demand just institutions, credible elections, and guaranteed freedoms.

2024 is also the year of the publication of our anniversary book "The Sentinels of Democracy". Because in this global tumult, Tournons La Page is watching, alerting and proposing. Our commitment is twofold: to support our members on a daily basis and to bring a strong voice in favor of democracy to regional and international decision-makers.

I would like to salute all the TLP activists, who are often exposed and always committed. I would also like to thank our technical and financial partners for their renewed confidence. Thanks to you, we have been able to expand our projects, strengthen our governance, and make TLP a real school of democracy.

In 2025, new challenges await us. Strengthening our structure, deepening our advocacy, and increasing the inclusion of young people and women in our dynamics will be at the heart of our action. Ten years is a long time, but it's only the beginning. Because as long as alternation remains an exception and democracy a fight, we will continue to march, together.

CONTEXT

The year 2024 is a continuation of the political upheavals that have marked the world, and in particular the African continent, in recent years. While democratic hopes are struggling to materialize, a worrying trend has been confirmed: the rise of military regimes and the questioning of electoral processes. After the coups in Mali, Guinea, Chad and Burkina Faso, the year 2023 saw Niger and Gabon fall under the control of the armed forces. These seizures of power were largely justified by their authors as a response to the excesses of previous regimes, considered corrupt and authoritarian. Yet they have not paved the way for more democratic governance. On the contrary, restrictions on civic space, attacks on fundamental freedoms and political uncertainty persist.

These events are part of a broader context of democratic crisis on the continent. Distrust of electoral institutions and the rule of law continues to grow, fuelling a sense of uncertainty and resignation. According to the Afrobarometer, although 66% of Africans continue to prefer democracy to any other form of government¹, a majority (62%) say they are dissatisfied with how it works in their country. This frustration creates a vicious circle: faced with civilian regimes perceived as corrupt and ineffective, part of the population comes to tolerate, or even support, military alternatives, despite the fact that they do not guarantee stability or respect for human rights.

The year 2024 marked a decisive turning point. With elections scheduled in 76 countries around the world – an all-time high – including fifteen in Africa, the issue of the ballot and its integrity has become a major issue for the future of democracy on the continent. However, recent examples show that electoral processes remain fragile. The presidential election of December 20, 2023 in the Democratic Republic of Congo is a striking illustration of this: marred by irregularities, fraud and intimidation, it reinforced distrust in institutions and highlighted the persistent challenges in ensuring free and transparent elections.

In this context, the need to strengthen democratic institutions, ensure credible elections and protect civic space is more urgent than ever. Africa has the opportunity to write a new, fairer and more democratic page, but this requires a strong commitment from national and international actors. Concrete tools – such as electoral reforms, increased support for civil society and diplomatic pressure for respect for fundamental rights – will be key to turning this hope into reality.

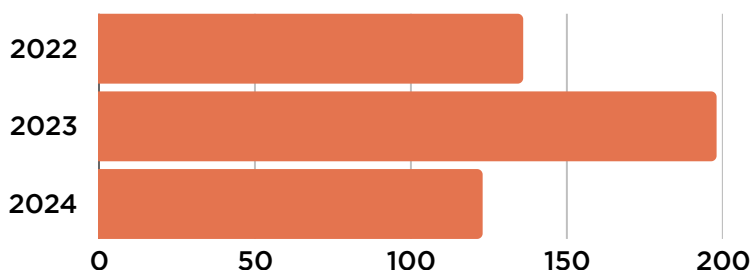

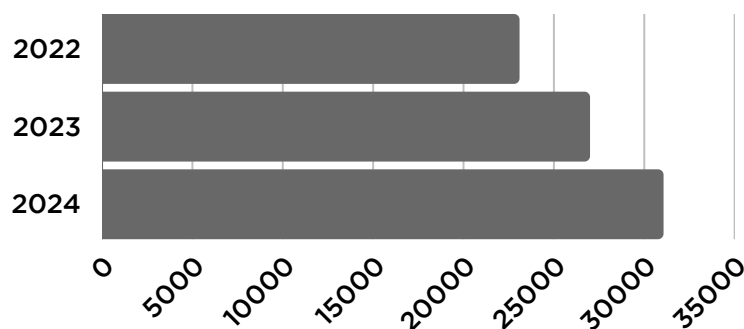

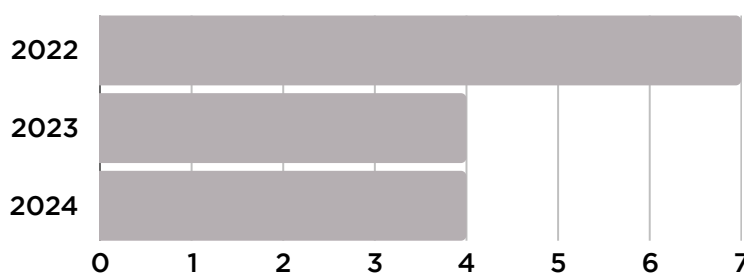
Evolution of the number of press articles between 2022 and 2024 :



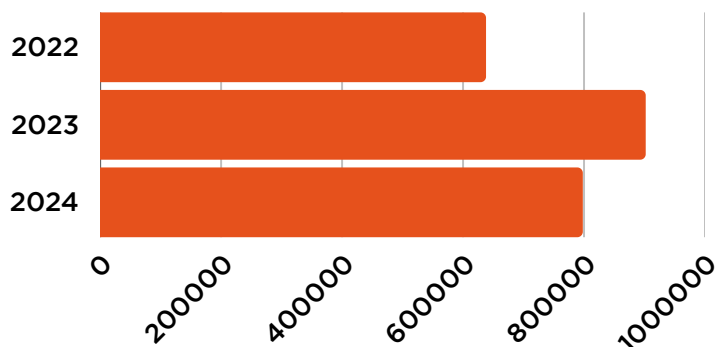
Evolution of the number of subscribers between 2022 and 2024 :



Evolution of the number of reports published between 2022 and 2024 :

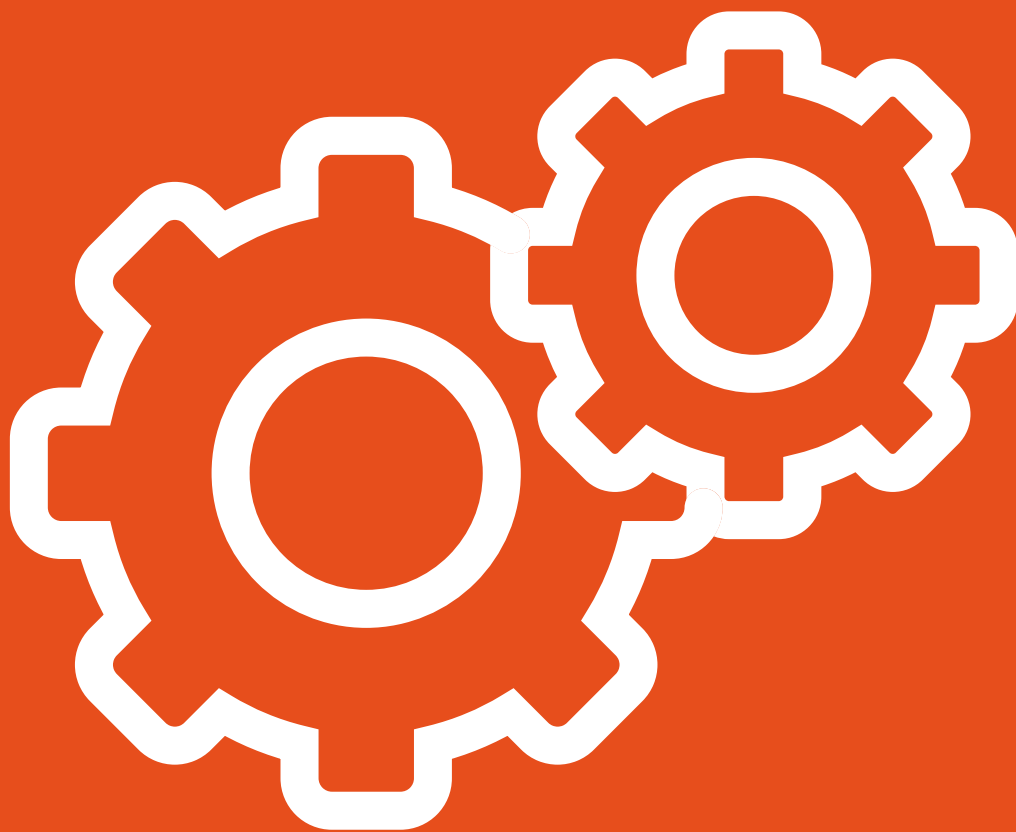


Evolution of the annual budget between 2022 and 2024 (in euros) :

OUR STRATEGIC AREAS

Tournons La Page has adopted a new strategic plan for 2023-2025 and four strategic priorities have been defined based on a shared assessment of the previous three-year plan :

01. Be a sounding board for mobilizations and demands for democracy

Since its creation, Tournons La Page's aim has been to echo the voices of democracy. This objective leads us to work on methods and activities to influence by and for the members of our network. It also leads us to prioritize collective dynamics, open up our actions and systematically build alliances.

03. Protecting members and building an international network of solidarity and support

Support members in the event of violations of their rights through an effective and operational emergency fund, organize and lead formal or informal groups and forge alliances ensuring protection for TLP activists, build and sustain a culture of security (digital, physical and emotional) within the TLP movement.

02. Make TLP a school of democracy capable of producing knowledge and analysis on democratic processes in Africa, by encouraging the cross-fertilization of expertise and promoting activist knowledge

Tournons La Page's success in bringing about lasting change in political and social processes depends in part on how we can become a learning organization, one that trains and trains itself. To this end, Tournons La Page aims to become a genuine school of democracy: innovation in terms of internal democracy; development of an internal and external training offer; intellectual production by and for members, in close liaison with the academic world; sharing and knowledge sharing.

04. Build a grassroots movement for democracy, involving the most vulnerable segments of society, by strengthening member organizations and coordinating the network

Leading the life of the movement, strengthening its governance in a democratic and inclusive way, building local roots, regional synergy and the development of the movement in a spirit of transparency and accountability to TLP's donors and partners.



01. BE A SOUNDING BOARD FOR MOBILIZATIONS AND DEMANDS FOR DEMOCRACY



Campaign against a third term in Senegal

The project was launched in 2023 and ran until the end of 2024. From the beginning of 2024, in January and February, several advocacy missions were carried out in Brussels and Paris. The aim of these missions was to raise awareness among various key actors – including NGOs, the European Commission and the French Ministry of Foreign Affairs – of the particular context of the presidential election in Senegal.

In the continuity of these actions, two important missions were carried out in Dakar. The first was to meet with various civil society organizations likely to join the new TLP coalition in Senegal. The second mission, for its part, aimed to promote TLP and to exchange with the diplomatic representations present in the field, in order to better understand and share the Senegalese context.

These steps led to the official creation of TLP-Senegal in May 2024. Shortly after, the coalition organized its first major public action: a press conference calling for the release of Oumar SYLLA and Mamadou Billo BAH, kidnapped in Conakry, Guinea on July 9, 2024.

Advocacy campaign for democratic alternation

On behalf of this project, TLP participated:

- to a mission to Kathmandu at the World Social Forum
- the Freedom Forum organized by the Human Rights Foundation (TLP has been participating since 2023) in Oslo;
- the Sahel-Europe Forum in Madrid (TLP has been participating since 2023);
- the Human Rights Defenders Platform organised by Frontline Defenders in Dublin;
- the Africa Global Summit in Lyon;
- the World Forum of Emmaus Initiatives in Poitiers;
- the World Forum for Democracy in Strasbourg;
- the Geneva Democracy Dialogue in Geneva and the team of the Working Group on Arbitrary Detention and the UN Special Rapporteur on Freedom of Expression;
- to a mission, in Lille at the invitation of Organisez-vous;
- a mission to Brussels, at the invitation of Search for Common Ground;
- at the International Meeting for Popular Education which took place in Abidjan.

A side event initiated by TLP was organised in collaboration with other civil society organisations such as Wademos and Oxfam to call for reform of ECOWAS. David Dosseh, coordinator of TLP-Togo, was among the speakers at this conference.



Election Observation in Chad

On May 6, 2024, more than 8 million Chadians were called to the polls to vote in the first round of the presidential election. This election came after 3 years of so-called military "transition" led by Mahamat Idriss Déby Itno, following the death of his father Idriss Déby Itno.

Through its members, TLP has organized itself to:

- analyse the electoral context (pre-election, election and post-election);
- deploy members in five provinces of the country (Guéra, Logone Oriental, Moyen-Chari, Ouaddaï and the City of N'Djamena representing 36% of the official electorate) for citizen observation of the vote, possible incidents and voting operations when possible, in compliance with the provisions of the electoral code;
- highlight possible good practices;
- make known its observations and propose recommendations to contribute to making electoral processes in Chad democratic and authentic.



Citizen mobilization in Central Africa

This project has strengthened citizen dynamics in several Central African countries. It has enabled the holding of unifying events such as charity football matches integrating messages on democracy, activist theatre forums, or conferences and meetings bringing together activists and young leaders. These initiatives have helped to make democratic demands resonate at the local and regional levels, while giving visibility to the mobilization of often marginalized layers of society.

Support for national initiatives (annual support fund)

Thanks to a structural fund, national TLP coalitions have been able to organize major public events (Festival of Democracy, International Day of Democracy, legal conferences), strengthen their internal governance through general assemblies, and produce advocacy and analysis content. This flexible support helped to anchor strong messages in favour of democracy locally.

02. TURNING TLP INTO A SCHOOL OF DEMOCRACY

Barometer of Democracy in Central Africa

A regional barometer of democracy has been developed as part of the NED project, mobilizing Central African coalitions around a participatory approach to democratic analysis. This barometer, enriched by feedback from activists, makes it possible to monitor the evolution of fundamental freedoms, political pluralism and the rule of law in the sub-region.

Public Legal Education and Specialized Analysis

The funds provided under the project have enabled the creation and dissemination of public legal tools for citizens, including mobile applications, information capsules and specialized reports. This content contributes to making the understanding of political and legislative issues accessible.

03. PROTECTING OUR MEMBERS AND BUILDING AN INTERNATIONAL NETWORK OF SOLIDARITY AND SUPPORT

Defenders' safety and international advocacy

The project was structured around two priorities: the protection of human rights defenders and international advocacy. Training in digital and physical security was provided to activists in high-risk contexts, in order to strengthen their individual and collective protection capacity. At the same time, TLP has carried out advocacy missions with international institutional actors – participation in the Accra Citizens' Summit, the Madrid Forum, meetings with Nordic governments, etc. to alert on the threats suffered by its members and ask for their support.

Engagement with the ACHPR

Both projects have contributed to joint advocacy actions with the African Commission on Human and Peoples' Rights, in particular to support the release of detained members of TLP - Guinea, and to highlight authoritarian excesses in various sub-Saharan countries.



04. BUILDING A GRASSROOTS MOVEMENT FOR DEMOCRACY

Youth and women involvement



The project has enabled a concrete broadening of the activist base, in particular through actions carried out in rural and isolated areas. Training and meetings were organized with women leaders and committed young people, with a view to consolidating activist networks and transmitting democratic values. These activities have strengthened the territorial network of the coalitions and fostered popular support for the ideals defended by TLP.

Support for local dynamics and coalition governance

The grants have strengthened the internal structuring of coalitions, supporting the organization of general assemblies, the consolidation of founding documents and the definition of strategic priorities on the ground. Through their local roots, these coalitions play an essential role in the popular appropriation of democratic issues.

Workshops for women activists and citizens' conferences

As part of the project, events specifically targeted women engaged in politics or civil society, with capacity-building modules, sharing of experiences, and adapted protection tools. At the same time, citizens' conferences were held for young people, on the themes of democratic participation, civil rights and commitment.

Why France's rejection in Africa ?

The rejection of French policy in Africa is profound, with the spectre of a *Françafrique* that persists on the continent. Based on this observation, Tournons La Page and the Centre de Recherches Internationales (CERI) of Sciences Po have carried out an action-research project to provide answers to this thorny question: Why France's rejection in Africa ? 470 civil society actors were interviewed in six French-speaking African countries: Benin, Cameroon, Chad, Côte d'Ivoire, Gabon and Niger. This mistrust of France and its policies was assessed on the basis of a range of indicators: health, education, security, the fight against corruption and the defence of democracy.

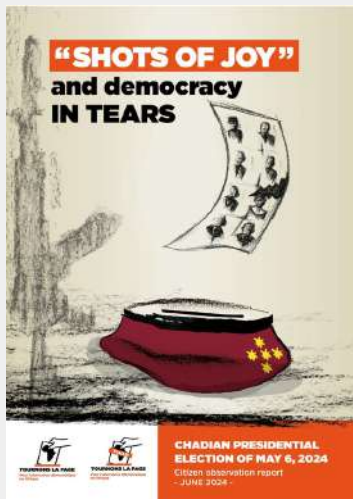


The Sentinels of Democracy - Tournons La Page: Ten of struggle

On October 15, 2014, a new transnational collective, Tournons La Page, launched an appeal: "In Africa as elsewhere, there can be no democracy without alternation." The few activists behind this column do not imagine that, ten years later, their international campaign calling for the denunciation of institutional coups d'état and support for democratic alternations would have turned into a powerful organization bringing together hundreds of associations and thousands of activists in fifteen African countries and Europe, representing a recognized force of protest and proposals on the continent. Today, Tournons La Page (TLP) is a coalition with which African heads of state and international diplomacy must reckon. While, in the new world disorder, the democratic model is in decline – in Africa even more than in the rest of the world – while in several countries of the continent, the political elites are going through a crisis of legitimacy, and the traditional counter-powers have been cut off from part of the population, the TLP sentinels have invented a new form of militancy. Capable of mobilizing on the ground as well as on social networks, of defending their cause in the chancelleries as well as in the most remote villages, they remind us that democracy is a daily struggle. TLP is also the unique story of a form of North-South cooperation where the African members of the coalition gradually took matters into their own hands, transforming the movement and shaping it in their image. This development has not been without turmoil. In this sense, the history of Tournons La Page is, on its scale, a unique democratic experience. This book retraces this unprecedented experience, giving a voice to those who led it, retracing their journey and the debates that have crossed this militant collective. It is the tumultuous march of the African continent over the past ten years, from the insurrection in Burkina Faso to the coups d'état in Niger and Gabon, that this book sheds a different light on.

"Shooting of joy" and democracy in tears - Report on the Chadian presidential election of 6 May 2024

On May 6, 2024, more than 8 million Chadians were called to the polls for the first round of the presidential election. The report, entitled 'Shooting Joy and Democracy in Tears', highlights the many political violence and irregularities that marred the electoral process. These incidents were documented by Tournons La Page Tchad (TLP-Chad) during their impartial and independent observation of the presidential election, carried out to verify that the process is democratic, authentic, and representative of the will of the Chadian people. The report highlights serious problems, including the deaths of several dozen people, including one candidate, the exclusion of several candidates, problems updating the electoral register, low participation of women, the inability to access results by polling station, and a severe deterioration in freedom of expression and the press.

We invite all members of civil society and Chad's international partners to consult this report for an in-depth understanding of the electoral issues in Chad and the challenges to be overcome in order to strengthen democracy in the country.

Central Africa: Democracy Barometer 2024

This report by Tournons La Page aims to provide an overview of democratic processes in four Central African countries (Cameroon, Republic of Congo, Gabon, Chad) in order to understand the issues and challenges. The latter have regimes that appear semi-authoritarian and are decried by multiple indicators of democracy. This report presents an in-depth overview of the situation in each country through a reading of the indicators of democracy and includes a comparative analysis of these countries, studying their similarities and divergences in order to discern regional trends.

During our investigation, we observed that in these Central African countries, endemic corruption affects all sectors, limiting democratic projects. The authorities control political life, with political scenes stripped down and/or orchestrated. The political classes find themselves instrumentalized in order to serve the regimes. Although laws on the fight against corruption or the representativeness of various segments of society have been adopted, their implementation remains insufficient. The political integration of women and minorities remains deficient. These factors thus hinder the development of a democratic culture.

The media landscape, although rich and emerging, faces many obstacles, including state control and repression and lack of financial resources. These media fail to promote debates and thus fully inform local societies. Access to the internet and political life in public spaces are monitored, especially during election periods.

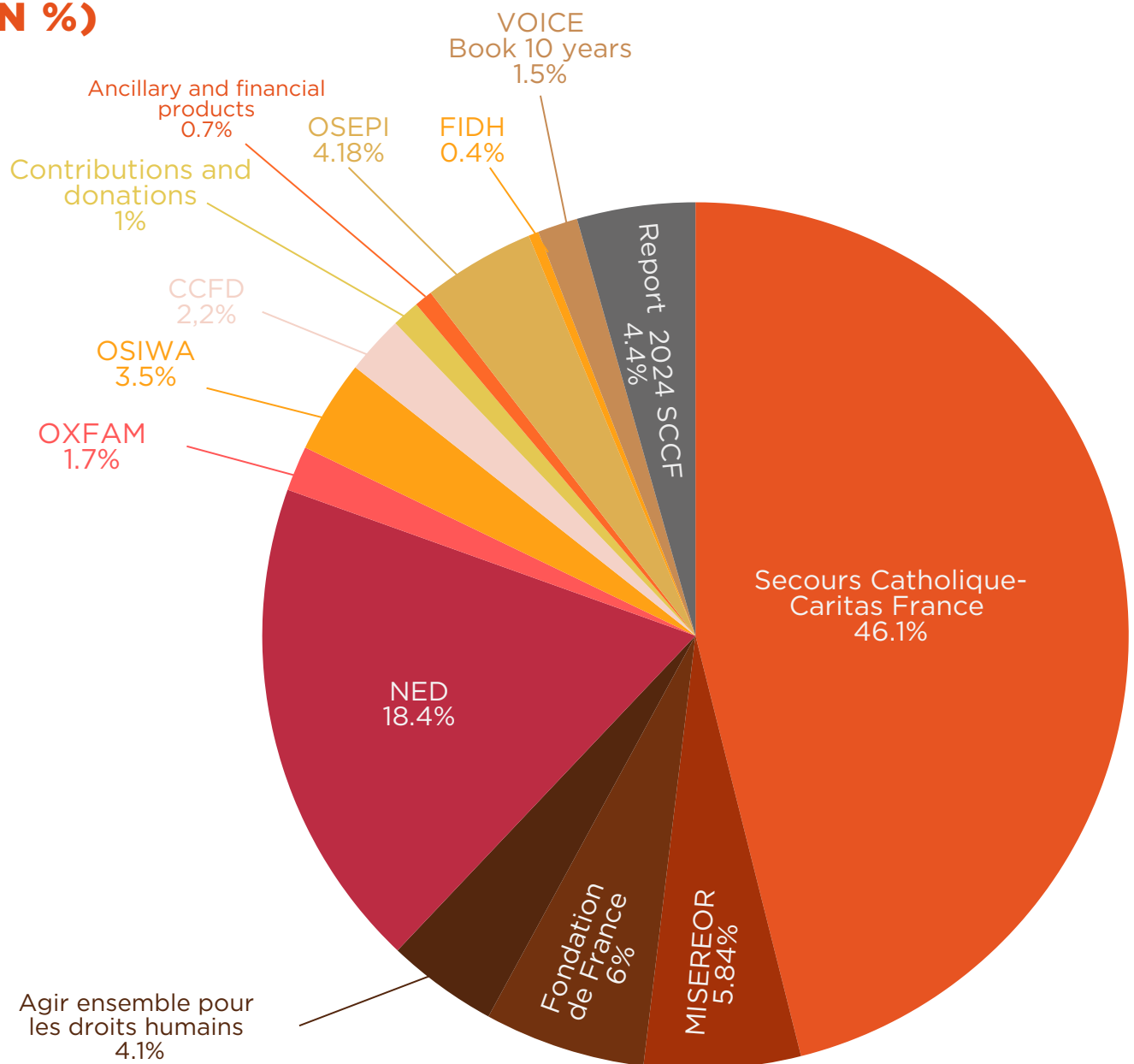

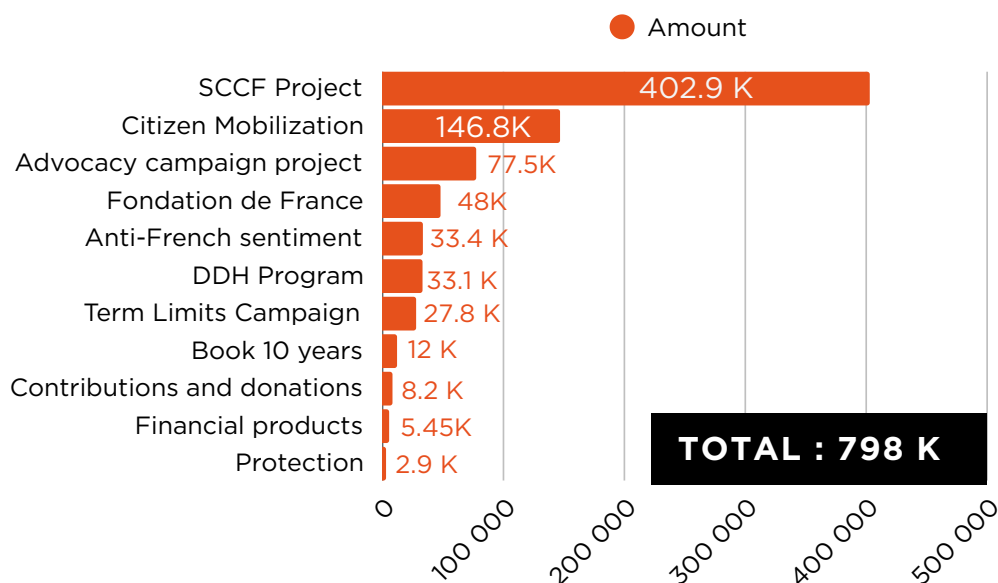
The diversification of the means of financing and the projects carried out by TLP continued in 2024. Secours Catholique – Caritas France (SCCF) remains a key technical and financial partner, accounting for 50% of the total funding and providing direct structural support to national coalitions.

The contribution of the national coalitions has been decisive in this dynamic of diversification, both through the quality of the cross-cutting projects they have been able to propose and support, and through the continuous improvement of management procedures and the rigour of the narrative and financial reports produced, guaranteeing transparent and efficient management of the funds entrusted.

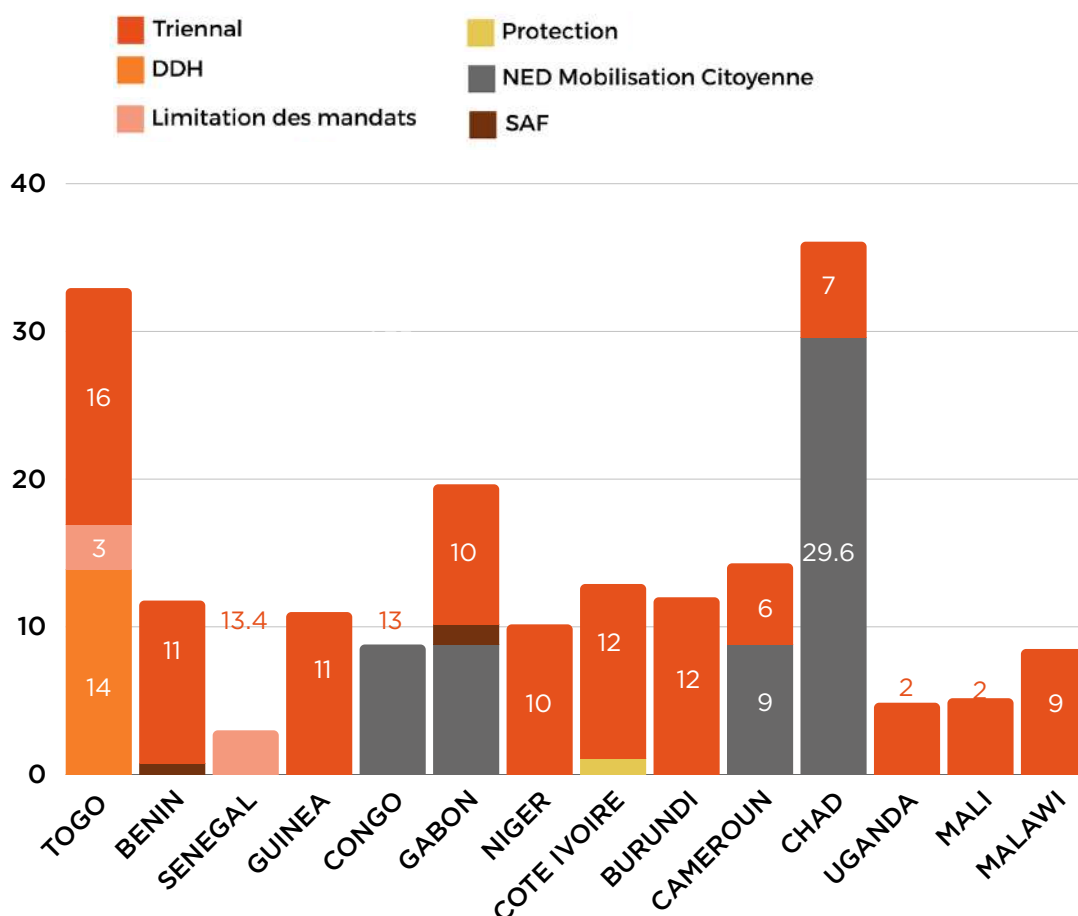
GRANT BY TECHNICAL AND FINANCIAL PARTNER (IN %)

STRUCTURAL FUNDS AND PROJECTS BY COALITION IN 2024 (IN THOUSANDS OF EUROS)



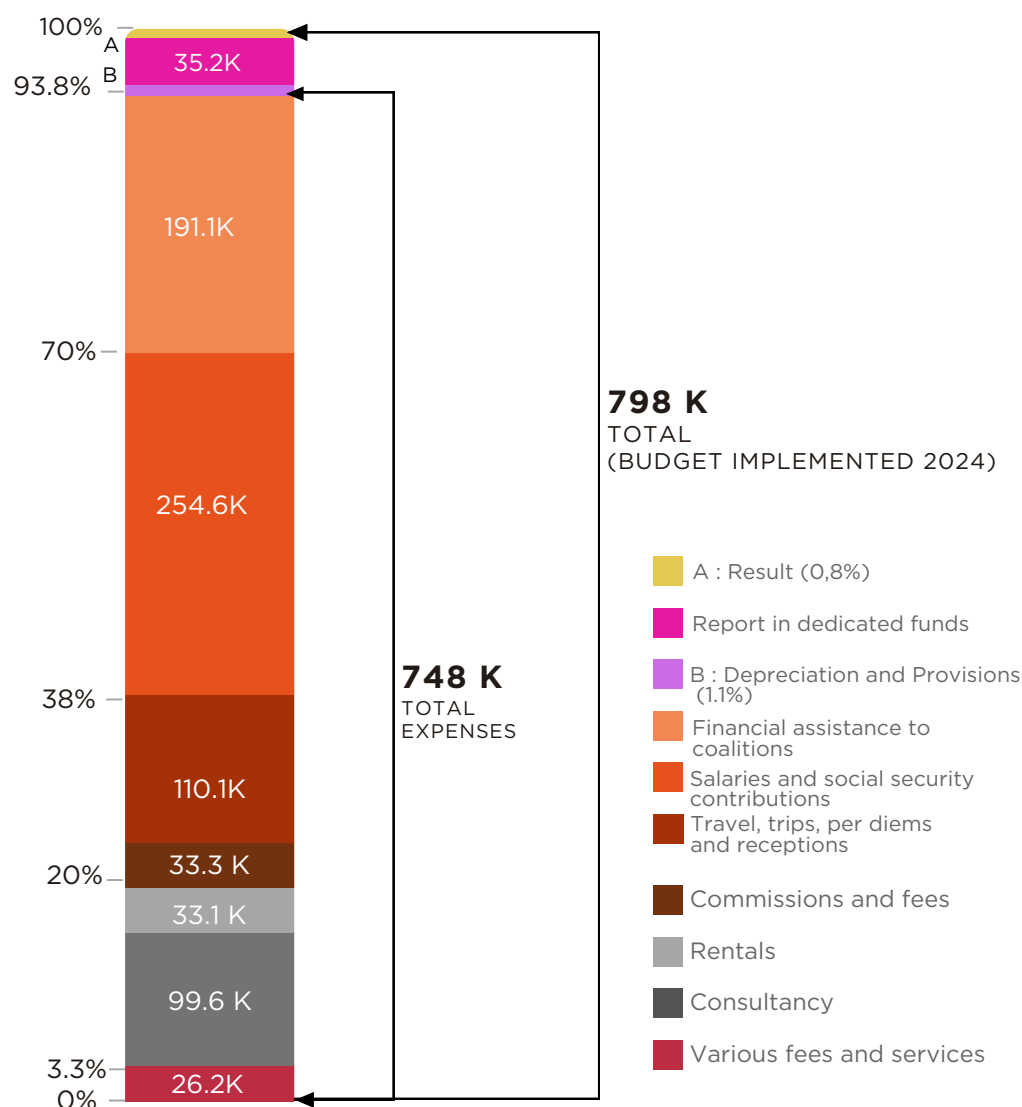
2024 EXPENDITURE BY TYPE OF EXPENSE

For the year 2024, the budget amounts to **€798 K**, distributed as follows:

- **€748K** concerns the expenses made,
- **€35.2K** concerns dedicated funds for multi-year projects
- **€8.5K** in depreciation and provisions
- **6 K€** of profit.

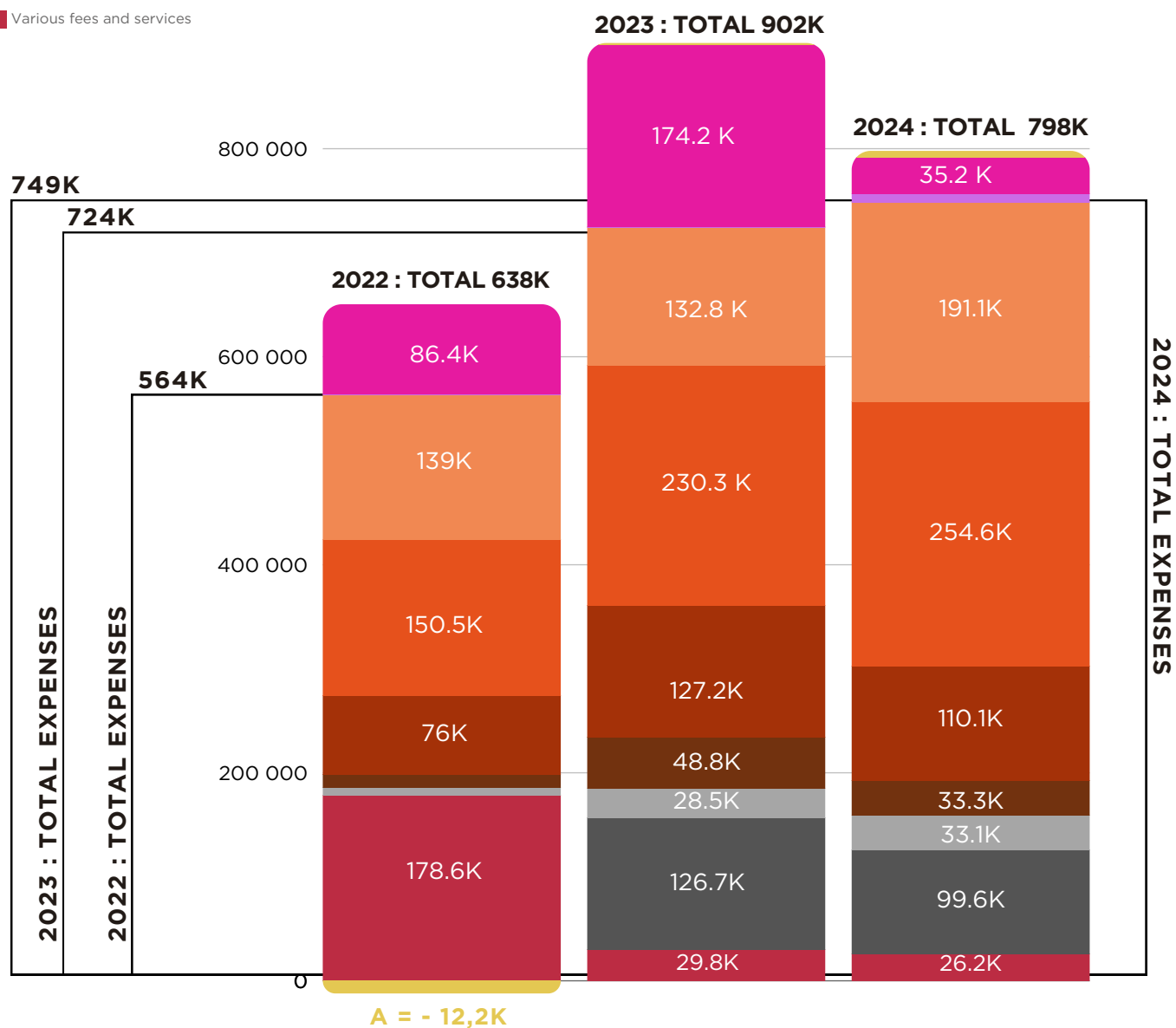
The expenses made, i.e. **€748K**, are broken down by type in the following graph:

- **€434.1K** or 58% was used for activities.
- **287.7K€** or 38% was used to cover administrative costs (HR, office rental).
- Finally, **€26.2K**, or about 4%, was allocated to cross-cutting and unforeseen actions.

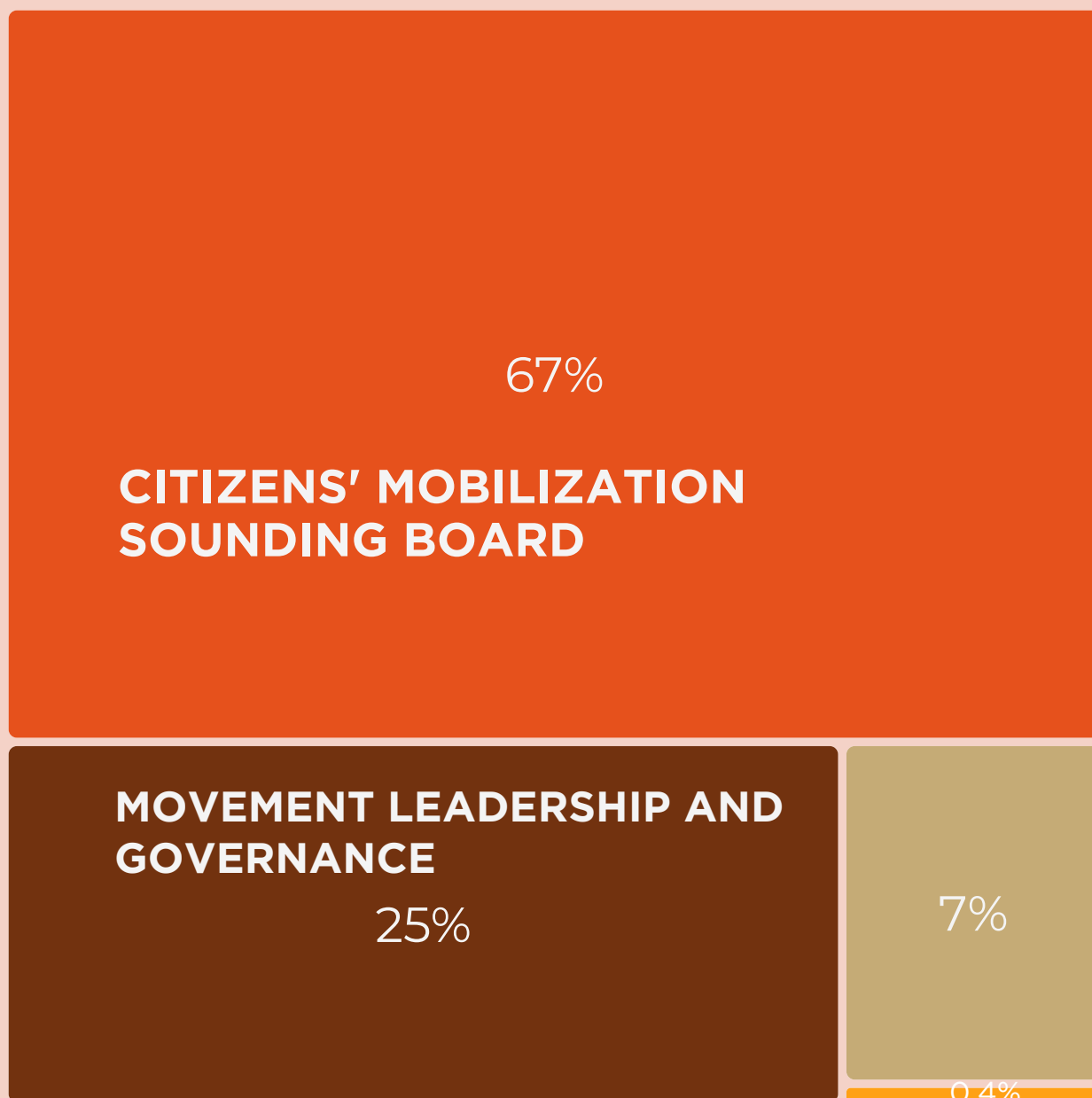


2022-2024 EXPENDITURES BY TYPE

WHO ARE WE?



TLP IN A FEW DATES

Tournons La Page (TLP) was created in October 2014 by civil society activists from Africa and Europe to challenge the international community on the lack of democratic alternation in a number of African countries, and on the negative consequences of this confiscation of power for stability and development. Initially conceived as an international campaign with a limited lifespan, Tournons La Page has gradually structured and developed to become a movement of organizations and public figures united in 16 coalitions by 2024. TLP has a strong collective identity, with a vast and heterogeneous collective but aware of being part of the same community of destiny. This makes it possible to initiate large-scale national and international mobilizations and to contribute to the fight against the arbitrariness of authoritarian regimes

→ 15 octobre 2014

Launch of Tournons La Page in the form of an international campaign with the publication of an appeal " In Africa as elsewhere, no democracy without alternation! " signed by 550 organizations and personalities from Africa and Europe.

→ 2015

Structuring of the movement around 6 national coalitions: Burundi, Cameroon, Congo, Gabon, DRC and France (composed of the Gabonese, Togolese and Congolese diasporas).

→ Janvier 2016

International meeting in Ouagadougou (Burkina Faso) and creation of an international COPIL.

→ 2017

Two new coalitions have joined Tournons La Page: Niger and Chad.

→ 2018

A new coalition is created in Côte d'Ivoire.

→ Décembre 2018

Human Rights Prize of the French Republic for Tournons La Page for its actions to fight corruption in Niger.

→ 2019

Three new coalitions created in Guinea, Togo and Europe.

→ Juillet 2019

First International General Assembly of Tournons La Page in Niamey.

→ 2020

African Movement of the Year Award from Africans Rising. TLP becomes an independent organisation with its own governance bodies.

→ Juillet 2021

2nd West African Citizens' Summit on Good Governance, Change, and Democracy in Cotonou. TLP hands over term limits to Beninese President Patrice Talon

→ Juillet 2022

TLP hands over the term limit stick to Botswanan President Mokgweetsi Masisi.

→ Septembre 2023

Large pan-African concert in Paris with more than 300 participants from the African diaspora.

→ Avril 2024

A new coalition joins TLP : Senegal

→ Août 2024

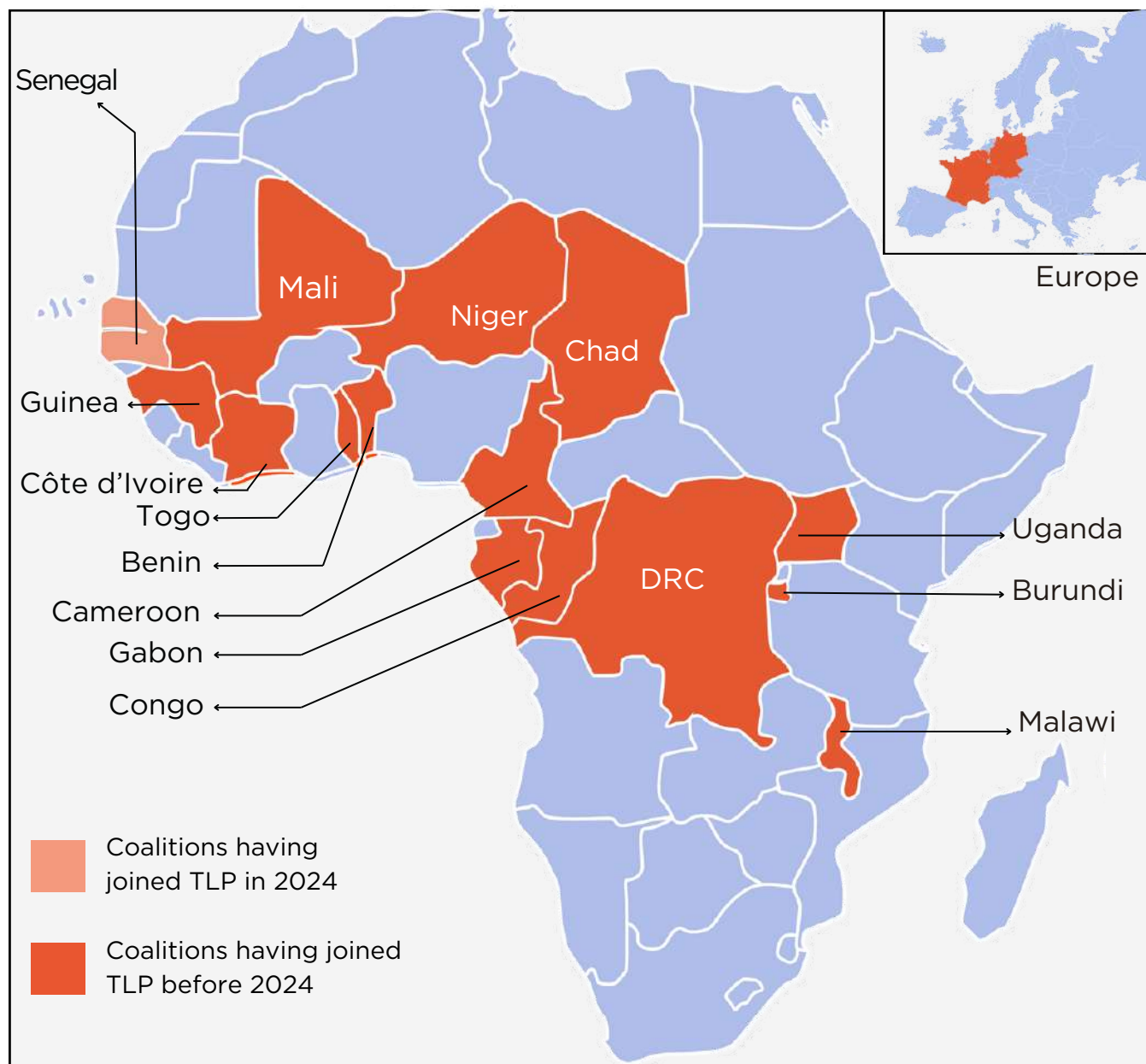
3rd West African Citizens' Summit on Good Governance, Alternation and Democracy in Accra. TLP brought together more than 300 young people from all over West Africa.

→ Octobre 2024

TLP's 10th anniversary. The event was celebrated through an evening that brought together hundreds of participants in Paris. On the occasion, the book " The Sentinels of Democracy: Let's Turn the Page - Ten Years of Struggle " was published.

OUR PARTNER NETWORKS



Since its creation in 1976, CRID has taken a critical look at globalization and development.
